

CURRICULAR PRACTICAL TRAINING REQUEST (CPT)

What is CPT?

Curricular Practical Training (CPT) is a temporary employment authorization that allows F-1 students to engage in an off campus academic internships or employment that is a required or an integral part of their academic curriculum.

- Occurs before the student's program end date on the Form I-20
- Each authorization is for one specific employer and for a specific period of time
 - Student can have multiple authorizations for the same time period. Please discuss with your Educational Advisor.
- o Student must secure the training opportunity before CPT can be authorized

Requirements

- Student is currently in valid F-1 status
- Student must have been lawfully enrolled full-time with the same SEVIS (I-20) number for at least one full academic year
- o Student must have secured an internship offer related to the major or field of study
- o Student is not studying English as second language
- Student will be enrolled in a major course that requires field work or an internship course (BUS 070A or BUS 070B)

How to Apply for CPT

- 1. Secure Internship and Offer Letter
- 2. Enroll in the internship/major Course
- 3. Submit CPT Request to ISC
- 4. Receive Authorization To learn the details of each step, please refer to International Student Center's CPT web page: https://www.pasadena.edu/international/cpt

- SSN support letter from your Educational (F-1) Advisor
- Social Security Number Application
- Valid passport
- Original signed Form I-20
