



## ASSIGNED GUARDIAN STATEMENT

A completed form and a copy of the U.S. guardians California driver's license/identification card must be on the file in the International Student Center before the student will admitted for the term applying (U.S. guardian address must match information below).

Pasadena City College (PCC) International Student Center (ISC) requires that students who are **under the age of 18** have a guardian over the age of 21 living within 75 miles of Pasadena City College. In the event of a personal emergency, accident, illness or incarceration, the State of California will require the signature of a guardian before offering assistance such as hospitalization or legal counsel. Pasadena City College is not permitted to act in place of the parent or guardian. If you are **under the age of 18**, you are **required** to have your parent submit a signed statement informing Pasadena City College who will be assigned as your guardian.
