Appeal Process:

Appeals are reviewed individually in the order they are received. Submit your petition as soon as registration dates are available in Lancerpoint. All required statements and supporting documentation must be attached for the appeal to be considered. Circumstances below marked with an * may require additional review and may take longer for a decision to be made.
